



PHOTOGRAPHS, AUDIO AND VIDEO RECORDINGS CONSENT FORM 2023-2024 SCHOOL YEAR

During the 2023-2024 school year, the Lycée Français Charles de Gaulle de Londres (the "Lycée") and/or the AEFE may take photographs, audio recordings and/or video recordings (including voice recordings) of your child, in the following instances:

- School trips (within the United Kingdom or abroad);
- Sport competitions and sporting events attended by pupils of the Lycée, within the Lycée premises or outside;
- Choir concerts, drama performances, talent shows, or other projects highlighting pupils' talents, organised by the Lycée or in which Lycée pupils participate;
- educational workshops, visits from speakers or other third parties;
- events/cultural projects/ecological projects (*Nuit des Idées, South Ken Kids Festival, World book day, Earth Week* etc.);
- Charity events organised by the Lycée or in which Lycée pupils participate;
- Festive events (school fair or equivalent, carnival etc.);
- Official ceremonies and commemorations (graduation ceremony, etc.);
- Common projects of the AEFE network schools, and in particular schools which are within the North West Europe and Scandinavia area;
- Participation in contests or competitions by classes or pupils of the Lycée;
- Meetings or exchanges with other schools;
- News bulletins/periodicals/blogs of the Lycée;
- Web radio organised by the Lycée or in which pupils of the Lycée participate.

Photographs and audio and/or video recordings (including the voice) of your child, taken or recorded in the abovementioned instances, can be used by the Lycée and/or l'AEFE on the following media:

Wall displays inside the Lycée premises, on the AEFE or Lycée's website, on the Lycée's blog, on social media channels (including those with a logo featured on the Lycée's website), in class padlets, in Yearbooks, and/or in written publications including in the press.
